General Survey

The strategic shift announced in 2012 came about in 2013. In January we formulated a new policy, which will guide our actions in the years ahead. In our research the successful Global Labour History programme will remain an important focus. The IISH will align its collection activities with this programme to concentrate on what has traditionally been the core business of the institute: labour and labour relations. In addition, collection policy will accommodate the sharply rising demand in research for data and digital archives. This will also require accelerated development of our digital infrastructure. The IISH aims to use new methods and techniques devised in the field known as digital humanities.

The mission reads:

Work and labour relations deeply influence how we live. The International Institute of Social History (IISH) examines how these relations develop globally over time. To conduct this historical research and support other researchers, we collect archives and data from all over the world. Established in 1935, the IISH is one of the world's leading research institutes on social history.

In the spring these choices became the foundation for a reorganization plan intended to solve the financial problems of the institute as well. Soon after I arrived in 2012, I discovered – as I noted in the previous annual report – an ongoing annual deficit in excess of half a million euros. Over the years the institute had failed to adjust operations to accommodate the longstanding systematic spending cuts by the Dutch government in scholarship and cultural heritage. Despite increases in spending, regular income was declining annually.

Lower staff numbers were therefore inevitable. The headcount had to be reduced by over 12 full-time equivalents to balance the budget. The unfortunate outcome of the reorganization was that 10 staff members lost their job. Parting with them was very sad and painful. Some had worked for the institute for decades.

With fewer people, the IISH is less productive. We cannot process as much material as before and are more selective in what we include. Scholarship in social history will be affected in the long run, as will society at large. After all, the IISH serves as a piece of global memory. The memory that we shape is now becoming more fragmented.

On 31 December the reorganization formally concluded. Financial order has been restored. The organization has become far less elaborate but is also better and more straightforward. Staff members are highly motivated to restore the institute to excellence in the near future. By the end of 2014, the institute is expected to be operating at full speed again. Afelonne Doek was appointed Director of Collections and Digital Infrastructure, Marien van der Heijden Head of Collection Development, Marja Musson Head of Collection Processing, and Jack Hofman Head of Public Services.

Other changes also benefit the institute. The parent organization of the IISH, the Royal Netherlands Academy of Arts and Sciences (KNAW), aims to invest in innovating research at its humanities institutes and has set aside 15 million euros to this end. Several of these institutes – including the IISH – intend to work together closely, especially in digital humanities and digital infrastructure. The substantial investments necessary in these fields exceed the capacity of individual institutes. In 2014 the directors of the institutes concerned will present a joint plan.

That the IISH remains a superior research institute despite all complications became clear in the summer, when the Netherlands Organization for Scientific Research (NWO) allocated two research grants to the institute in a call awarding seven grants to forty proposals. The IISH received an NWO grant for the research project ‘Slaves, commodities and logistics’ (€ 740,946) and has a leading role in the project ‘Four centuries of labour camps. War, rehabilitation, ethnicity,’ awarded to the NIOD (€ 810,442). In addition, interest in the Global Labour History research programme continues to grow and was the subject of the opening keynote at the annual North American Labor History Conference in Detroit. Staff members were invited to report on this field at several other scholarly gatherings as well. In an

interview with the *International Labor and Working Class History (ILWCH)* editorial board in May 2011 the late professor David Montgomery, one of the foremost academics specializing in US labour history, stated: ‘Where could you have a more logical place to do international history, starting from early modern times on than Amsterdam? It has been central you know, will be for a long time to come.’

On 15 November 2013, senior researcher Dr Ulbe Bosma was officially appointed professor of the endowed chair in International and Comparative History at VU University Amsterdam. Professor Bosma is the sixth professor among the research staff at the IISH.

At the collection department, the European project Heritage of the People’s Europe (HOPE) was completed and approved by the European Commission. It has resulted in the inclusion of nearly one million digital objects of the IISH and affiliated European archives in the Europeana (European digital library, archive, and museum) and in the Social History Portal, where the metadata and the digital collections of the member institutes may be searched jointly and featured. In addition, the HOPE project yielded what is known as a Shared Object Repository, which serves as a foundation for the digital infrastructure of the IISH.

The institute acquired 147 (accruals to) collections, ten of which are digital only. Important accessions included the personal papers and library of Jakob Moneta (1914-2012), the collection of Dr Siagzar Berelian on the social and political history of Iran 1960-2000, the papers of the Russian Shelgunov Family (1819-1914) and a collection of 1,835 digitized audiocassettes and tape recordings with the voices of workers in Bolivia and an academic analysis of their history (1965-1996).

In June 2013 the only remaining handwritten page from the *Communist Manifesto* (1848) by Karl Marx and the first edition of *Das Kapital*, Volume I (1867), featuring handwritten corrections by Marx in the margins, were added to UNESCO’s prestigious Memory of the World Register, thereby once again affirming the importance of the IISH as a world heritage institution.

Such importance is at times perceived more clearly abroad than in our own country. In December the IISH welcomed Bolivian Vice President Dr Alvaro García Linera at his request. He arrived with a large entourage, including Bolivia’s ambassador to the Netherlands Eduardo Rodríguez Veltzé.

Because of a new mode of counting the output figures of, among others, publications and lectures declined in 2013. As of 2013 the institute takes into account the publications by IISH staff members only. Previously publications by honorary and visiting fellows were also included in the figures.

Social Survey

At the end of 2013, the IISH staff comprised 89 people. Most of them (65) were employed by the KNAW, including 62 with permanent employment contracts and 3 on a temporary contract. Nearly all staff members of the IISH Foundation hold temporary contracts (15), while a few hold permanent ones (4). One staff member is working as part of Sociale Werkvoorziening (social employment service), one was posted, and four were part of a training programme.

12 In 2013 the institute experienced a drastic reorganization, in which 10 staff members had to be let go. Vacancies arising from the departure of employees were not filled, and some expiring temporary contracts were not extended.

The majority of the staff is employed part-time. The ratios of part-time and full-time staff are 65% and 35%, respectively. Men remain the majority (63%). They are also overrepresented in the higher salary grades, while women continue to prevail in the middle salary grades. In 2013 the average age was 50.

Seventeen new staff members were hired in 2013. Altogether, 40 staff members left the institute, among whom 15 had been permanently employed by the KNAW or the IISH Foundation.

The rate of absenteeism for 2013 was 4.3%, which was 1.62% lower than it had been the previous year, thanks to the decline in long-term absenteeism due to illness.

In 2013 the administration met 3 times with the Staff Council (sc). The ambience at these meetings was cordial.

Staff Council

The Staff Council (sc) again comprised 5 persons in 2013. The sc members were Ineke Kellij (chair), Ineke Eisma (deputy chair), Cornelia Dickhoff (secretary), Jerry de Vries, and Gerben van der Meulen (Arbo working conditions). As agreed in 2012, the director and the chair of the Staff Council alternated chairing the meetings.

The Staff Council met 4 times in 2013. To notify staff in time about all steps, involve them throughout, and offer a platform for alternative ideas, a meeting was convened with all staff members on 2 occasions.

Topics discussed included clustering the humanities institutes and remodelling the IISH. The most important item in the meetings with the director was the reorganization of the IISH.

The *Voornemen tot reorganisatie* [Intention to reorganize] presented by the director revealed that the reorganization would be very extensive. Given the resulting consequences (forced redundancies), the Staff Council opted from the outset to scrupulously observe procedures. Regrettably, the sc ultimately had to issue a negative recommendation regarding the *Voornemen tot reorganisatie*.

In December the announcements about placement and non-placement, respectively, marked the reorganization.

In 2014 the sc also aims to engage in candid exchanges with the director and to do its utmost to protect staff interests.

Research

Major Developments

As in previous years, permanent research staff declined in number in 2013. As part of the reorganization, Jacques van Gerwen, a senior researcher on economic history, was transferred to the Collections Department. We aim to reverse this trend in the years ahead.

International interest in our Global Labour History research programme continues to grow. It was featured in the opening keynote of the annual North American Labor History Conference in Detroit, as well as at several other scholarly gatherings, where staff members were invited to present reports. The new labour history association founded in France immediately expressed strong interest in Global Labour History. The special issue of the journal *le Mouvement Social* that we edited on the topic received a lot of positive feedback.

The biannual New-York based journal *International Labor and Working Class History* invited our staff to edit two special issues, the first on strikes and social conflicts (edited by Raquel Varela and Sjaak van der Velden), the second on oil workers in Iran (edited by Touraj Atabaki, with contributions by himself, Peyman Jafari, and Maral Jefroudi).

Christian De Vito edited a special issue of the new journal *Workers of the World* on Global Labour History, in which he extended the time frame deeper into the past, adding a dimension to the project. Our own *International Review of Social History* increased circulation again and remained a major forum for labour historians worldwide.

Maintaining and developing infrastructural facilities for social historians consistently remained pivotal at the institute. In October we there-

fore hosted the first meeting of the European Labour History Network, established theme-based working groups, and launched conference preparations. We are working with the Weatherhead Initiative on Global History (Harvard University) to construct a worldwide network for global historians, with a special emphasis on Africa, Asia, and Latin America. And our colleague Rossana Barragán was elected member of the Steering Committee of the new Latin American Network on Global History. Together with Amsterdam University Press, the open-access *Work around the Globe* monograph series was launched.

Connections with digital humanities were strengthened in several ways. In June the Clio Infra website was launched (www.clio-infra.eu). This set of interconnected historical databases on worldwide social, economic, and institutional indicators over the past five centuries includes a special focus on the past 200 years. The Global Collaboratory on the History of Labour Relations (<https://collab.iisg.nl/web/labour-relations>) organized workshops in Addis Ababa and Amsterdam and expanded its databases considerably. A new datahub on global strike data is under development.

Conferences

We organized several important conferences, including *In the Same Boat* on shipbuilding worldwide after 1945 (coordinators: Marcel van der Linden and Raquel Varela); *Selling Sex in the City* (coordinators: Elise van Nederveen Meerkerk, Lex Heerma van Voss, and Magaly Rodríguez); *Comparative Social History of Labour in the Oil Industry* (coordinator: Touraj Atabaki); and *Global Historical Population* (coordinators: Richard Zijdeman, Pat Manning, and Jan Luiten van Zanden). The Global Collaboratory on the History of Labour Relations (coordinator: Karin Hofmeester) organized workshops in Lisbon on labour relations in the Lusophone World, and in Estoril on Archaeology and Labour Relations in Africa.

Grants

The institute received an nwo grant toward the research project *Slaves, commodities and logistics: The direct and indirect, the immediate and long-term economic impact of eighteenth-century Dutch Republic transatlantic slave-*

based activities, covering two PhD candidates and one postdoc, who will investigate the importance of the slave trade and slavery-related output for the Dutch economy in the eighteenth century (€ 740,946). The project is being carried out in conjunction with Leiden University (Professor Henk den Heijer) and VU University Amsterdam (Professor Karel Davids) and will be launched in 2014.

The institute took the lead in the successful application for an NWO grant toward the research project *Four centuries of labour camps. War, rehabilitation, ethnicity*, which is being conducted as a joint effort with the NIOD and will be carried out by three postdocs and a PhD candidate (€ 810,442).

Finally, the Historical Sample of the Netherlands obtained a seed money grant (€ 100,000) via what is known as the CLARIAH project (Common Laboratory for Research in the Arts and Humanities). The project will demonstrate opportunities for extending and combining the national HSN database with data for the Dutch province of Zeeland.

The SNS REAAL fellowship programme will be discontinued on 1 February 2014. We hope that in the near future we will be able to set up a new programme.

Outreach

We have been exploring new ways to reach a broader readership and audience. We did this through public events at Spui25, including the Annual Sadighi lecture (Saïd Amir Arjomand); through the exhibition *The Soviet Myth*, co-organized by Gijs Kessler and featured in Assen and Moscow (20,000 – 30,000 visitors in Assen, many more in Moscow); and by starting an Open Access book series with Amsterdam University Press, edited by Aad Blok, Karin Hofmeester, Gijs Kessler, and Jan Lucassen. The *de Volkskrant* IISH Thesis Award was presented for the fourth time for the best history MA thesis in the Netherlands in the past year.

Collections

Major Developments

As a result of the HOPE (Heritage of the People's Europe) project, IISH collections are present in Europeana, Europe's digital museum, library and archive, and the international Social History Portal. This has significantly improved access to our collections on various platforms and enables researchers to use the IISH collections in context with other national and international collections.

We have been upgrading our archival descriptions to meet the revised international standard for encoded archival descriptions (EAD) and featured a new presentation of our archival inventories in our online catalogue.

Digitizing the collections acquired for the IISH prior to World War II by De Centrale Arbeiders Verzekerings- en Depositobank (Central Workers' Insurance and Deposit Bank) continued. The archives digitized in this 'Centrale Project' this year include the collections of Karl Kautsky, Lev Davidovich Trotsky, Pierre Ramus, and Georg von Vollmar. The digitized archives will be available online in early 2014; the systems that enable presentation within the context of the archival description are nearly complete.

Furthermore a new functionality has been added to our online catalogue, enabling researchers to request material for the reading room. The system has been operational since July and has resulted in an increase in requests. Automating this process necessitated reviewing and adapting some of the related procedures in the department.

Digital Infrastructure

In the final year of HOPE, huge efforts were made to finalize the Shared Object Repository (SOR) as part of the IISH Work Package responsibilities and to complete the technical infrastructure. The Shared Object Repository stores all digitized objects of the IISH as well as digitized objects from some European partners, and will be developed into a Trusted Digital Repository in the next years.

Development of the portal of the Clio Infra project (international datasets for reconstructing global inequality) continued and progressed.

Several additional projects to improve and support the work processes were conducted in conjunction with the Department of Collection Processing and Public Services.

Accessions

The institute acquired 147 collections (accruals in some cases), ten of which are exclusively digital. Two very important collections in a sense returned to the IISH: the library of Ferdinand Domela Nieuwenhuis, which had moved to the Domela Museum in Heerenveen in 1999; and the last part of the *Sozialistische Monatshefte* records. The latter collection was originally acquired in 1939. Stored at the institute's Paris branch, the archive was confiscated first by the Nazis and in 1945 by the Soviet Union, which kept it in Moscow, from where the records were shipped to Amsterdam only in 2002. A small part (approximately 50 cm) had remained in Germany, however, and was kept at the Bundesarchiv. In 2013 the IISH and the Bundesarchiv reached an agreement to reunite the two parts. The accrual will be merged with the records already in Amsterdam, and the complete archive will be digitized within the Centrale Project.

Some particularly noteworthy acquisitions are:

- The personal papers and library of Jakob Moneta (1914-2012). Moneta joined the youth section of the Sozialistische Arbeiterpartei Deutschlands as a teenager. He became interested in Trotsky's ideas. In 1933, he left for Palestine, worked on a kibbutz, and joined the Histadrut trade union movement, but abandoned Zionism in the late 1930s. In 1939-1941 he was interned by the British. In 1948 Moneta returned to Germany, where he worked first in Cologne and later

in Frankfurt as a journalist and translator. He then became active in the Trotskyist movement and wrote under a pseudonym in the press of the Fourth International. The movement followed the ‘entrism’ strategy – wherever the movement was not strong enough to operate in public, the members joined leftist parties to propagate their ideas from within. Moneta belonged to the Sozialistische Partei Deutschlands, until he was expelled in 1990. He then became a member and even joined the board of the Partei des Demokratischen Sozialismus. Moneta was also active in the trade union movement, especially in IG Metall, where he long edited the journal. He was a close friend of Ernest Mandel, and his extensive correspondence reflects his vast network.

- The Berelian collection on social and political history of Iran 1960-2000. Dr Siagzar Berelian, an anaesthesiologist and established political activist based in Britain, donated a unique and well-organized archive of publications, leaflets, and pamphlets by the Iranian opposition, inside the country as well as from his exile in the years before the Revolution of 1979, the revolutionary years of 1978-1982, and the post-revolutionary period until 2000. The documents originate from students, women, labour, political parties and groups, and ethnic and religious entities. The Berelian collection also comprises a vast library of books published outside Iran between 1960 and 2000 and rare audio and video documents on Iran’s revolutionary days, illustrating how the last classical revolution of the twentieth century came about.
- Andries Sternheim (1890-1944), active in the international trade union movement in the 1920s and 30s, was a librarian, editor, and researcher employed by the International Confederation of Free Trade Unions (ICFTU), and conducted research on the subject of leisure time. Most of his personal papers have been lost, but Bertus Mulder, who spent years conducting research on the life and work of Sternheim, entrusted his research archive to the institute, including a great many original photographs.
- Jan de Boo (b. 1934) was closely involved in the foreign operations of the CPN (Communist Party of the Netherlands) from 1951 to 1991. He was active in the Algemeen Nederlands Jeugd Verbond (general Dutch youth league, ANJV); he served on its executive and as such participated in various international youth festivals in Eastern Europe and the Soviet Union. He was also the editor of the foreign desk of the party’s daily newspaper *De Waarheid*. His personal papers consist largely of documents from the period 1977-1991 and shed light, for

example, on the history of the international communist movement and the foreign policy of the CPN.

- **Workers in Bolivia: Their voices and an analysis of their history (1965-1996).** This collection consists of 1,835 digitized audiocassettes and tapes in two groups: workers' voices (recordings of Meetings of Peasant Congresses, Miners' Congresses, Artisans, Indigenous Movements, Coca Leaf peasants, Leftist Political Parties) and voices of leaders and intellectuals (academic events, meetings and seminars providing academic and political contexts). Each recording was extensively catalogued, allowing sophisticated searches by names, events, dates, subjects, places, etc. This large project was carried out by the IISH Latin American Desk and its team in cooperation with MUSEF (La Paz, Bolivia). The collection is unique in that it preserves oral histories of events not recorded in written documents and reflects 30 years of workers' memories.
- **The Shelgunov family papers (1819-1914).** This collection documents the 'official life' of three generations of a Russian family through original legal documents and deeds of ownership. Nikolay Vasil'evich Shelgunov (1824-1891) was a revolutionary democrat, journalist, and literary critic. He was in contact with Alexander Herzen, Nikolay Ogarev, and Nikolay Chernyshevsky, contributed to the journals *Russkoe slovo*, *Sovremennik*, and *Vek*, participated in the revolutionary movement of the 1860s and introduced the Russian public to Friedrich Engels' work *The Condition of the Working Class in England*. His son Nikolay Nikolaevich Shelgunov (1865-1909) was an engineer and the director of a metallurgical factory in Sulin, in the Rostov-on-Don region; he was ultimately murdered by workers. Nikolay Nikolaevich's daughter Aleksandra Nikolaevna Shelgunova (b. 1894) inherited the family property and became involved in complex legal disputes over its management. The documents include official letters to the authorities, testaments, diplomas from schools and institutes, and certificates, deeds of ownership, records of service, payments, court decisions, birth certificates, military tickets, debt securities, mortgages, documents and correspondence with law firms, lists of property, and factory papers.
- **The Asian Students Association (ASA) records.** The ASA covers the Asia-Pacific region, and has its main offices in Hong Kong. Many cadre members of political organizations in the region (especially from Nepal and the Philippines) acquired their first experiences organizing

here. The collection contains interesting correspondence from the early years (1980s) and most congress reports.

- The Michael Bedford collection. In the early 1990s, Michael Bedford conducted an extensive series of interviews in the Philippines with people involved in labour unions and human rights groups, with priests involved in Liberation Theology, members of the New People's Army, and right wing vigilantes. None of these primary materials have been published.
- The P.C. Joshi Archives on Contemporary History. This collection of rare documents relating to the history of leftist movements in India is held at the Jawaharlal Nehru University in New Delhi. The IISH South Asia Desk contributed to a digitization project to preserve documents that are in a very bad material condition. Some 60,000 pages were digitized and classified.
- A collection of booklets, brochures, pamphlets, and newsletters of the labour, student, and communist parties and trade unions in Pakistan (late 1960s to the present) and the Pakistan Fisher Folk Forum; some digital-born materials and a wonderful set of digital copies of posters of the Trade Union Federation Punjab, the Labour Union Lahore and the PTCL United Workers Alliance.
- *Relazione sulla colonia Eritrea del R. Commissario civile deputato Ferdinando Martini per gli esercizi 1902-1907* (Rome, 1913), a four-volumes report by the Italian Governor on governmental and private initiatives in the colony. The publication is one of the main sources on economic, labour, and social history of Eritrea during these years and is quite rare. Especially the last volume, which features unique maps, is extremely difficult to find.
- A collection of Marxist classics in Amharic (e.g., the *Communist Manifesto* and *Capital*) and dictionaries of Marxist terms and concepts from the 1970s and 80s, propagating the ideology in Ethiopia and capturing it in a single official version.
- Ethiopian socialist and revolutionary periodicals in Amharic from the 1970s and 1980 (including some extremely rare specimens, as they were prohibited after the fall of the Marxist-Leninist regime, when possession of these periodicals became very dangerous).
- Notebook of Jean Lacoste, silk manufacturer in Amsterdam, 1730-1733. The notebook contains 47 pages with writings and 24 samples of ribbons in various colours (NEHA acquisition).
- Ernst Maurer, *Gewerbkunde oder Kenntniss aller Gewerbe besonders für Deutschlands Jünglinge, die sich ein Gewerbe wählen wollten*. Erster [- Zweiter]

Theil (Leipzig, August Lebrecht Reinicke, 1805). This publication lists over 270 professions, from *Ahlenschmied* and *Alaunsieder* to *Zuckerbäcker*, *Zuckersieder* and *Zwilligmacher*, and provides information on training, working conditions, and career prospects (NEHA acquisition).

Access

Despite the sweeping reorganization that marked the year, the Collection Processing Department achieved several important milestones.

In 2013 the Collection Processing Department started describing collections of different material types in a new way. Whereas previously such a collection would have been divided into its components, and individual descriptions would be generated of each item, the items are now being kept together and described as a single unit, just as happens with archives. This increases efficiency and makes it easier to learn that such a collection exists. More importantly, this practice preserves the context and makes recording information about the context possible. Last year, 4 collections were processed this way, including the collection of Joop den Uyl awards (28 items) and the photograph collection of photographer Ad Volker (over 40,450 photographs and negatives). The Press Museum's collection of Ies Spreekmeester comprising over 3,000 drawings also became accessible due to this way of describing.

Other types of materials, such as photographs and objects, are now more often described and stored with the archives as well in order to preserve the context. In the past, they would have been separated and catalogued individually. This way of describing has made it possible to arrange and describe 17 archives, among them the records of the Van den Muyzenberg Foundation.

The next major project addressed this way and currently being processed is the Brünn-Harris-Watts collection. In addition to the archive, this collection comprises a vast quantity of underground journals,

leaflets, pamphlets, and all kinds of other publications, written and published by conscientious objectors and conscripts, especially from the United States during the Vietnam War.

Over 12,000 books were added to the catalogue, with most titles coming from the Levensverzekeringsmaatschappij [life insurance company] 'Utrecht' (a NEHA collection). Altogether, 307 new archives were registered and 247 new journal titles catalogued.

On the occasion of the 40th anniversary of the Transnational Institute in 2014, a staff member arranged its archive. Susan George, who was closely involved in founding the Transnational Institute, visited the IISH to view documents from its early days. In the course of her visit she also had a look at her own papers, which she had previously entrusted to the IISH.

Preservation

In the aftermath of remodelling the stacks, much time was spent placing, moving, inspecting, and re-registering collections.

We continued digitizing the collections acquired for the IISH prior to World War II by De Centrale Arbeiders Verzekerings- en Depositobank [Central Workers' Insurance and Deposit Bank]. Two new projects were launched in the framework of the Metamorfoze national preservation programme: the personal papers of Hendrik de Man, and a section from the nvv archive. They are scheduled to be completed in 2014 and 2015.

A grant from the Stichting Boek & Wurm funded restoring three fragile parts of our collection: a set of leaflets from the early years of the State of Israel; a series of large-size East-European newspapers from the early twentieth century; and a special collection of manuals and treatises for merchants from the sixteenth to the eighteenth centuries.

Services

Reading Room

Visits to the reading room and concurrent physical use of the collections increased slightly. Requests for books rose substantially. Numbers of digital and analogue copies commissioned lagged slightly behind last year, presumably because people increasingly make their own scans in the reading room. The reading room welcomed visitors from 36 different countries.

A new lending system was introduced for books and journals, enabling online reservations. This system is still under development for archival documents.

Communications

Major Developments

IISH staff members appeared in newspapers and journals, and the institute assisted with radio and television broadcasts. Ulbe Bosma, for example, was a guest on the Radio 1 programme *Casa Luna*, in recognition of his inaugural lecture, and Marja Musson appeared on the television show *Verborgen Verleden* [Hidden past], which was recorded at the institute's reading room.

Early in the year, the IISH launched a digital newsletter featuring a new layout. It is sent monthly to about 1,300 subscribers.

In the context of History Month, dedicated to the theme 'Sovereign and People,' the IISH organized the debate "Oh Oh Oranje? Arbeiders en het koningshuis, 1813-1960" [Uh oh Orange? Workers and the Dutch royal family, 1813-1960] at Spui²⁵ and a well-attended walking tour of Amsterdam's Jordaan neighbourhood, 'de Oranjefurie van 1887' [the Orange frenzy of 1887].

In December the history master thesis award from the daily *de Volkskrant* and the IISH was presented for the fourth time. This year's winner was the Ancient History student Stefan Penders, with an essay on 'Imperial waters: Roman river god art in context.' An interview with him was published in *de Volkskrant* to mark the occasion.

The institute was active on various social media. The Flickr photographs of the IISH were viewed more than 900,000 times. The number of our followers on Twitter and Facebook continued to increase. The institute was also active on youtube, scribd, pinterest, and librarything-books.

We organized about 52 guided tours, mainly to students and participants at meetings held at the institute.

Website

Additions and presentations on the website related in part to current events. One such highlight for the IISH was the inscription on the UNESCO Memory of the World Register of the only surviving handwritten page of Karl Marx's *Communist Manifesto* (1848) and the first edition of volume I of *Das Kapital* (1867). The history and wanderings of these manuscripts were documented in a web presentation.

Upon the death of Nelson Mandela, various materials from the niza's Dutch anti-apartheid collections were posted on the website. Following the succession in the Netherlands, another presentation featured the history of anti-Orangism, with a wealth of digitized original materials. In recognition of Press Freedom Day, we wrote about a conflict of Louise Michel with the freedom of expression in France. Following the innovation of the institute's website, the website of the Biografisch Woordenboek van het Socialisme en de Arbeidersbeweging in Nederland (BWSA) was revised as well. It now has a new look, a new content management system, and the same design as the external website.

We launched a large web exhibition on neo-Malthusianism in France, complementing an earlier exhibition about neo-Malthusianism in the Netherlands. It sheds light on family planning and its controversies in France in the nineteenth and twentieth centuries, based on source materials at the IISH.

Naturally, our website once again featured news about publications, congresses, exhibitions, and new collections. Selected themes were featured from our celebrated poster collection, concerning the independence of Mozambique, the social history of Bangladesh, and Dutch solidarity with Chile.

Friends of the Institute

The Friends underwent major changes. Jan Lucassen, first chairman until 2012, transferred this task to Jaap Kloosterman. Because of Jaap's retirement in the summer of this year, Huub Sanders succeeded him in June 2013.

At the Friends' Day held on 31 January, IISH researcher Touraj Atabaki delivered a lecture on the institute's activities in Iran, Turkey, and Central Asia. During the meeting of 13 June, Professor Duco Hellema and the Friends' board member Dr Jacco Pekelder, both of Utrecht University, spoke on *A Radical Decade: the Netherlands in the Seventies*. At both meetings selected recent accessions were presented.
